



**SELECTION/REJECTION OF UNINSURED MOTORISTS COVERAGE  
SELECTION OF UNDERINSURED MOTORISTS COVERAGE

The Arkansas Code, Section 23-89-403 (a), provides that each automobile liability insurance policy issued in the state respecting vehicles garaged in the state must offer uninsured motorists coverage. This coverage offers protection to you should you suffer bodily injury or death caused by an uninsured motor vehicle. The statute also permits those who purchase uninsured motorists coverage to purchase uninsured motorists property damage coverage for damage to an insured vehicle in excess of two hundred dollars (\$200) (Section 23-89-404).

However, pursuant to Section 23-89-403 (b), and 23-89-404 (c) you have the right to reject uninsured motorists coverage. This rejection shall continue in this policy and any renewal policies until you withdraw the rejection in writing.

Underinsured Motorists Coverage may also be purchased in limits at least equal to the financial responsibility limits prescribed for bodily injury. Underinsured motorists coverage permits you to recover from us when you are legally entitled to recover from the owner or operator of another motor vehicle who has insufficient liability insurance to compensate you. Underinsured motorists coverage may not be purchased if uninsured motorists coverage has been rejected.

NOTE: You may purchase uninsured and underinsured motorists coverage in an amount up to the liability limits of this policy. If uninsured motorists coverage is not rejected or an amount of coverage selected, uninsured motorists coverage shall be provided at the minimum amounts set out above. If a limit for underinsured motorists coverage has not been selected, no coverage will be afforded.
