UNINSURED MOTORISTS COVERAGE - BODILY INJURY

Uninsured Motorists Coverage provides protection against damages for bodily injury which the insured is legally entitled to recover from the owner or operator of a motor vehicle which: has no insurance; is an insured vehicle with liability limits lower than the minimum Financial Responsibility Limits; is an insured vehicle but coverage for an accident is disputed by the insurer for more than 60 days; which is a hit-and-run vehicle; or, whose insurer is declared insolvent. Refer to your policy for the prevailing coverage provisions.

In accordance with the laws of Utah, your motor vehicle policy shall automatically include Uninsured Motorists Coverage at limits equal to your policy Bodily Injury Liability Limits unless you reject such coverage or select lower limits, but not lower than the minimum Financial Responsibility Limits, as indicated below. Please see Exhibit A, attached to this application, which sets forth the premium associated with certain common policy Bodily Injury Liability Limits available for purchase.

I wish to reject Uninsured Motorists Bodily Injury Coverage.

I wish to select Uninsured Motorists Coverage at limits equal to the minimum Financial Responsibility Limits of \$25,000 each person/\$65,000 each accident, or \$80,000 each accident Combined Single Limit (CSL). UNINSURED MOTORISTS COVERAGE - PROPERTY DAMAGE

If you do not have collision coverage, you may purchase Uninsured Motorists Property Damage Coverage. This coverage is subject to a limit equal to the actual cash value of the motor vehicle, or the limit selected below, whichever is less.

Uninsured Motorists Property Damage Coverage provides protection against property damage which the insured is legally entitled to recover from the owner or operator of a motor vehicle which has no insurance; is an insured vehicle with liability limits lower than the minimum Financial Responsibility Limits; is an insured vehicle but coverage for an accident is disputed by the insurer for more than 60 days; which is a hit-and-run vehicle; or, whose insurer is declared insolvent. Uninsured Motorists Property Damage Coverage is subject to a \$250 deductible.

IF YOU HAVE ELECTED TO PURCHASE A LARGE DEDUCTIBLE RATING PLAN, THE DEDUCTIBLE RATING PLAN SHOWN ON THE DEDUCTIBLE ENDORSEMENT IN YOUR POLICY SHALL APPLY AS THE UNINSURED MOTORISTS COVERAGE PROPERTY DAMAGE DEDUCTIBLE.

UNDERINSURED MOTORISTS COVERAGE

Underinsured Motorists Coverage provides protection against damages for bodily injury which the insured is legally entitled to recover from the owner or operator of an underinsured motor vehicle which is a vehicle that has coverage under a liability policy at the time of the accident but such coverage is not enough to pay the full amount of damages the insured is legally entitled to recover from the accident.

In accordance with the laws of Utah, your motor vehicle liability policy shall automatically include Underinsured Motorists Coverage at limits equal to your policy Bodily Injury Liability Limits unless you reject such coverage or select lower limits, but not lower than the minimum limits required by Utah law, as indicated below. Please see Exhibit A, attached to this application, which sets forth the premium associated with certain common policy Bodily Injury Liability Limits available for purchase.

- I wish to select Underinsured Motorists Coverage at the minimum limits under Utah law for this coverage of \$10,000 each person/\$20,000 each accident or \$20,000 each accident Combined Single Limit (CSL). The Underinsured Motorists Coverage limits will be either split (each person/each accident) or a combined single limit (CSL), consistent with the policy Bodily Injury Liability Limits.
