Uninsured Motorists coverage provides protection against damages for bodily injury and property damage that an insured is legally entitled to recover from the owner or driver of a motor vehicle: (1) for which no liability policy applies; (2) for which an insurer denies coverage or is or becomes insolvent; (3) which is a hit-and-run vehicle; or, (4) that is underinsured. An underinsured motor vehicle is one for which the sum of all liability policies is less than the sum of the limits of Uninsured Motorists coverage applicable to the insured, or for which the available liability insurance has been reduced by payment to others to an amount less than the Uninsured Motorists coverage limit. Refer to your policy for the prevailing coverage provisions.

In accordance with the laws of Vermont, your policy insuring against liability arising out of the ownership, maintenance or use of any motor vehicle shall automatically include Uninsured Motorists coverage for bodily injury at limits which are not less than \$50,000 each person/ \$100,000 each accident or \$100,000 each accident combined single limit (CSL). If your policy's Bodily Injury Liability limits are greater than these minimum limits, your policy will automatically include Uninsured Motorists coverage at limits equal to your policy's Bodily Injury Liability limits, unless you select lower limits below.

- I wish to select Uninsured Motorists coverage at the minimum limits of \$50,000 each person/ \$100,000 each accident or \$100,000 each accident, combined single limit (CSL). The Uninsured Motorists coverage limits will be either split (each person/ each accident) or a combined single limit (CSL), consistent with the Bodily Injury Liability limit on your policy.
- I wish to select limits equal to the policy Bodily Injury Liability limits.
- Other limits greater than the minimum limits, but less than the policy Bodily Injury Liability limits. (Specify)

Your policy will automatically include \$10,000 each accident for Uninsured Motorists Property Damage coverage regardless of the amount of your Uninsured Motorists Bodily Injury. Uninsured Motorists Property Damage coverage is subject to a \$150 deductible, unless other direct damage coverage is valid and collectible.

I understand that my coverage election shall apply on the policy or policies in effect at the time this form is executed and all future renewal policies until I notify the Company IN WRITING of any changes.
